THE COURT ORDERS THAT:

- 1. The first plaintiffs are to file and serve any further evidence upon which they intend to rely in support of the winding up of the third defendant (Kappa Investment Holdings Pty Ltd ACN 623 580 076), on or before 14 March 2025.
- 2. Any party or person intending to oppose the application to wind up the third defendant is to file and serve their affidavits in opposition on or before 28 March 2025.
- 3. The first plaintiffs are to file and serve their written submissions in support of their application to wind up the third defendant, not exceeding 10 pages in length, by 4 April 2025.
- 4. Any party who opposes the application to wind up the third defendant is to file and serve their written submissions in response to the application to wind up the third defendant, not exceeding 10 pages in length, by 17 April 2025.
- 5. The whole of the proceeding to the National Operations Registrar for allocation to a docket judge, noting that the first plaintiffs' application to wind up the third defendant will be ready for hearing on a date to be allocated on or after 22 April 2025, with an estimate of half a day, and that the first plaintiffs have requested that the proceeding also be listed for case management hearing on that date.
- 6. Liberty to apply on two days' notice in writing.



THE COURT NOTES THAT:

- 7. The plaintiffs and the second, fourth, sixth, seventh, tenth, twenty-first and twenty-second defendants informed the Court that they intend to file an interlocutory process, on or before 14 March 2025, seeking that the second, fourth, sixth, seventh, tenth, twenty-first and twenty-second defendants be joined as plaintiffs to the proceeding and amending the originating process so that those entities will seek winding up orders against others of the defendants.
- 8. Following the hearing to be scheduled in accordance with Order 5 above the plaintiffs anticipate they will seek a hearing date for the balance of relief sought in the originating process (as amended) in around mid-May 2025 or other time convenient to the Court.
